
### Meets for the Office outside the Country:



#### L. Field Meets and Visits:-

The number of field visits to the Ahwazi areas, headquarters for Palestinian groups, training bases for Palestinians at the Al-Quds Special military base and Al-Aziziyya Special Military Base reached 67 visits and meets through the year. Persons who visited them were the Office director, the intelligence department director and heads of assigned departments.

#### M. Failures.

No failure took place in the Office work except the matter of Ahwazis voluntarily return to Iran where they could influence the mental and ideological side for Ahwazis like the influence of some thing on the department plans in the renewing its work toward the Ahwazi issue.

### N. Intelligence Handicaps and Suggestions to Fix It.

- 1. Shortage in sedans designated for Continuation officers, ten officers in the office could not obtain cars and they are included on the list to receive them according. According to the order we suggest an increase in the amount of cars for our office in relation to the officers.
- 2. The Office takes into account an intelligence department. Since its creation in 1994, it works using the precautionary and risky directions. The intelligence directorates work on that basis, including intelligence officers within the intelligence directorate and others. However we find that opportunities to send special delegations to work or humanitarian delegations, some of them were not given permission even on a limited basis from the Office in spite of them being intelligence officers distinguished in their work. Some of them have language, national security and political science degrees.
- 3. By our Office not participating in the internet site, it led to us missing a lot of statements from Palestinian groups and news of groups which have relations with Arab liberation movements in the world. This made us rely on sources to tell us the news. Our news and information on that was through electronic mail (e-mail). We suggest allocating an internet site for the Office.













They were distributed 11 to M4, 9 to M5, 5 to other directorates and 274 meets to serve the work of the Office and its concerns. The details are stated below:-




#### Meets with Palestinian and Ahwazi officials inside the country:-

The job of the Office is to solidify and perpetuate relations with Palestinian and Ahwazi groups in and outside of Iraq, likewise with influential figures in Palestinian and Ahwazi circles, through meets with them. It is also to extend the political and intelligence channels of communication with them. The number of instances is 27. The most important of them are as follows.

#### Third. Occasions to Host Delegations.

The work of the Office is to host Palestinian and Ahwazi delegations by invitation by the Office after receiving basic approval to participate in conferences which are held in Iraq. There were 13 events, and they are as follows:-

- 1. A delegation from the Democratic Front headed by Palestinian Fahd Suleiman, member of the political office and official of foreign relations.
- 2. A delegation from the Palestinian Revolutionary Communist Party headed by Arabi Awad, (director general).
- 3. A delegation from the Popular Struggle Front (splinter group) headed by Khalid Abdel-Majid (director general).
- A delegation from the Islamic Jihad Movement headed by Palestinian Abu Tareq Ziyad Rashid Hussein, (the military official).
- 5. A delegation from the Popular Front headed by Palestinian Maher Al-taher, member of the political office (a number of times).
- 6. A delegation from the Popular Struggle Front, headed by Khalid Fawzi (Political Office member).
- 7. A delegation from the Popular Front headed by A'arif A'rif Arafat (member of the Political Office).
- 8. A delegation from the Palestinian Liberation Front (splinter group) headed by Palestinian Yassin Ma'tuq (member of the Political Office).

#### D. Deputy Officer in Charge of the Office-Director of Intelligence Services:-

The number of information reports sent to the Deputy Officer in Charge of the Office is 188. The reason in the decrease of total information sent up this year from 2001 is that the work, according to instructions, is that the information will be transferred to other directorates for the purpose of using it without writing to the Service director and getting approval to transfer it, as was previously done. The most important is as follows:-

- 2. Information on the meet with a delegation from the Popular Front for the Liberation of Palestine.

- 8. Information on verdicts of execution for a number of Ahwazis.
- 9. Information on Ahwazi and the possibility to use him as an opportunity for Front work [referring to liberation fronts].
- 10. Information on sending and approval for his travel.

#### E. <u>Discussions</u> with State and Other Security Agencies.

The number of discussions of the Office with other state agencies and its establishments with other state security agencies number 462 reports. They include the office executing all kinds of administrative demands from Palestinian groups and their unions and the Arab Front

for the Liberation of Ahwaz with the above agencies. These discussions had intelligence information which the Continuation Office used toward Palestinians and Ahwazis. We will mention the most important as follows:

- E. Administrative and financial assistance office provides to Palestinian groups, the Arab Front for the Liberation of Ahwaz and the unions connected to it, they are:-

travel, residence and visas information was achieved where the number of instances for Palestinians and Ahwazis 299 instances. The assistance consists of granting visas, renewals and extensions, documents and passports. The details are represented below:-

First. Granting exit and return visas numbered 243 visas and documents.

Second. Iraqi travel documents extended, numbered 33 documents.

Third. Iraqi travel documents renewed, numbered 62 documents.

A discussion to develop relations with them had taken place and the director general had been invited to visit the country. Six. Opening political and intelligence channels with the Revolutionary Committees Movement, the director general and his deputy came to the country. Seven. Building secret relations with officials from secret wings and special operations of Palestinian groups in Syria (the Popular Front-General Command, Fatah Movement and the Popular Front) through meets with them in Syria and exploiting the military and intelligence information they possess. Moving on Eight. with a mission, because he has for press influence in Palestinian, Lebanese, and Hizballah circles and contacting him. Opening a special electronic mail account for the Office (e-mail) and Nine. using it to exchange information with our sources abroad. Setting up weekly meets with directors of Palestinian organizations and Ten. offices in the country. Setting up weekly meets with the heads of popular and technical unions in Eleven. the country. Twelve. Direct administrative control over the Association of Arabs Expelled from Kuwait. Thirteen. Re-equipping and training of Palestinian fighters at the Al-Quds Special Military Base according to approval from the Presidency of the Republic-the Secretary, in accordance with their letter numbered 530 / K on 22 January 2002. Fourteen. Organizing courses for Palestinian fighters present in the country at the Al-Ouds Special Military Base (Course of the Fedayiin of Janin AL-Samoud, and a specialized explosives course) notifying the Services director in according with our announcement 125 on 11 May 2002 about the program for these courses. Persons who visited them were the Office director, the intelligence department director and heads of assigned departments.

# M. Failures.

No failure took place in the Office work except the matter of Ahwazis voluntarily return to Iran where they could influence the mental and ideological side for Ahwazis like the influence of some thing on the department plans in the renewing its work toward the Ahwazi issue.

# N. Intelligence Handicaps and Suggestions to Fix It.

- 1. Shortage in sedans designated for Continuation officers, ten officers in the office could not obtain cars and they are included on the list to receive them according. According to the order we suggest an increase in the amount of cars for our office in relation to the officers.
- 2. The Office takes into account an intelligence department. Since its creation in 1994, it works using the precautionary and risky directions. The intelligence directorates work on that basis, including intelligence officers within the intelligence directorate and others. However, we find that opportunities to send special or humanitarian delegations, some of them were not permitted, even on a limited basis from the Office, in spite of them being intelligence officers distinguished in their work. Some of them have language, national security and political science degrees.
- 3. By our Office not participating in the internet site, it led to us missing a lot of statements from Palestinian groups and news of groups which have relations with Arab liberation movements in the world. This made us rely on sources to tell us the news. Our news and information on that was through electronic mail (e-mail). We suggest allocating an internet site for the Office.
