Pages 44-55: Lists of names containing about 44 officers who received rewards for an unmentioned mission; the rewards ranged from 122 to 40,100 Iraqi Dinars and all the names were previously mentioned on pages 4-33 of this file.

Pages 68-71, 73-75: Correspondence between the SOFS and the INOC regarding a letter from an Iraqi female named Nazah Nin Muhammad Karim to 'Uday Saddam Hussein containing a request to process her husband's pension documents. The request came about because her husband died when he carried out a suicide mission on 19 Jul 2000, and exploded Ibn Sina Hotel during the presence of US, UK citizens and officials from Iraqi opposition parties. The mission was assigned to him by an order from the General Command of Fedayeen Saddam. The letter is also enclosed with a report, in which his wife mentioned the most important missions that he carried out. Some of the missions involved exploding a booby trapped car in front of the Kurdish and Communist Parties Headquarters by IIS orders, exploding a car during the convoy of Danial Meteron (wife of former French President Françoise Meteron) to Halabjah City in which he killed 40 people, poisoning opposition party members by IIS orders, he was also given a gun and spray substance by Jalal-al-Din Al-Talibani to assassinate Kurdish officials who were against the Kurdish Party but he handed over the substance and gun to Fedayeen Saddam Command without completing the mission.

Pages 76-80, 84-88: Correspondence between the SOFS and the INOC concerning an unavailable letter from an Iraqi civilian, whose alias is Sadiq Amin 'Abd-al-Haq. The letter contains unspecified information about a burned GMC car which belonged to Fedayeen Saddam Command. These pages also include an order from 'Uday Saddam Hussein to form an investigation committee to look into the information. The committee members were Staff Major General Maki Hamudat, Staff Brigadier General Ahmad Saddak, Staff Colonel Qatih Sa'id Hammu, and Brigadier General Hilan Khudayr. The committee decision was that the information was incorrect. These pages also include a request from Staff Brigadier General Armored (Fighters Directorate) Fuad Hamid Zaydan Mikhlif Al-Tikriti to 'Uday Saddam Hussayn to join the Fedayeen Saddam, but his request was refused because there is an Iraqi rule that doesn't allow anyone to work in the Fighter Directorate and the Fedayeen Saddam simultaneously.

Pages 89-104: Contain correspondence between the SOFS and the INOC concerning a request from the Iraqi female Sabriyyah Kazim Surur to 'Uday Saddam Hussein to release her son Lieutenant Qasim Waqqr Karun from jail, because he was accused of killing a civilian. These pages also include a request from several commandos asking about reasons for their discharge from the Fedayeen.

Pages 105-106: Memoranda dated from 27 to 30 Jun 2001 between the SOFS and INOC regarding stopping monthly payment rewards for several officers and paying out others. Pages 107-112: Memoranda dated from 28 May to 1 Jul 2001 between the SOFS, the INOC and the Iraqi Intelligence Service regarding information provided by a Jordanian National of Palestinian origin named 'Abd-al-Karim Al-Adham. He informed the IIS about high-ranking Iraqi officials involved in the selling of Uranium to Americans

through Jordanian brokers, also information about smuggling Red Mercury to Arabian Gulf merchants in Oman.
