M16 gave Khan training courses on how to best use the TNT and how to study the area effectively to obtain the best possible damage to the building. The memos include a description of the operation and his personal information. He was born in 1963 Al-Sulaymaniyyah. Khan also kidnapped one of the Iranian Intelligence Agents. Page 20 contains the names of the crew, who planned the bombing operation, they were: M58 Director, Diya' Ghannawi 'Abdallah Al-Sulaymaniyyah Center Director, 'Ali 'Arif Hasan Al- Sulaymaniyyah Davison Director, 'Ali Muhammad Hamid Tracking Officer, Hasan Mar'i Muhsin Pages 11-13, 15, 17, 19, 21, 32, 34, 37, 39, 43, 57, 63, 67 contain empty paper. Pages 27-30 contain IIS internal memos requesting information on Sami Amin Al-Allusi, who was working for a British Company called Gulf Catering and recently for a Swiss Company called "Kutikna". Page 31, 35 and 33 contain IIS memos including a request from Wajih Qasim Muhammad Al-Qaysi to register the British International "Arisco" Limited to his group "Al-Sadid". The IIS memo granted approvals for al-Qaysi because it was noted on the memo that Al-Qaysi was a retired IIS officer and later became a Source for M4 dated 8 October 2000. Page 36 contains requests for information on Najah 'Abd-al-Rahman Hasan. Page 38 contains permission for an entry visa for the Irish citizen Diyar Mu'ayyad Kulacil O' Donovan. Pages 40-42 and 44- 46 contain correspondence between M5 and M4 about verifying information on a so-called "Iragi Earthquake" opposition organization as the IIS found a letter issued from London addressed to Iragi TV, attached with it was a brochure for the above-mentioned organization, dated 13 September 2000. Pages 47-50 contain IIS "For Your Information" memos about information on Sylva George Tyrrhenian, who was a British citizen of Lebanese origin. She was granted a oneyear residence visa in Iraq. The pages also include her photo and her Arab and Foreigner Arrival Card, dated 20 September 2000.
