Male 1	Thank God for your safety. Have a seat. Who is [Inaudible]? How is the lighting?
Male 2	[Inaudible] personal for you
Male 1	God willing
Male 2	<p>Mr. President Leader, may God protect you and guide you. We [Inaudible] your Excellency yesterday [Inaudible] in the area. There were [Inaudible] for the Air Defense [Inaudible] in a gradual fashion. [Inaudible] related to the warning and control tools [Inaudible]. What we should [Inaudible], what we should leave and what we should withdraw [Inaudible] for balancing [Inaudible]. For getting the tools we in the Air Defense the required [Inaudible]. Indeed the plan was executed in that direction [Inaudible]. The other point (may God protect you) is that we saw that the missiles that were fired were determined to be nine to ten high. Yesterday we were ten but [Inaudible] only nine and the activities [Inaudible] on the cities. They chose [Inaudible]. We received the approval of your Excellency to [Inaudible] battle [Inaudible] from the inside in the area of al-‘Amarah [Inaudible] and the area of al-Hay and there were other [Inaudible] based on the area of al-Shatrah [Inaudible] al-Jariha [Inaudible]. The hardest loss, the hardest [Inaudible], but we were forced to do this [Inaudible]. The fact is that this plan was stopped because of the orders that were issued yesterday. We received orders to return to our sites [Inaudible] Sir, north of line 31. The [Inaudible] of the executed plan and we saw a presence [Inaudible] in the area south of al-Razzazah [Inaudible] with high altitudes. We thought of how we can lower the enemy. One of the points that we thought of is to create a death area. So we deployed a group of different kinds of traps, such as [Inaudible]... al-Razzazah area and the [Inaudible] area and [Inaudible] area. Al-Razzazah area [Inaudible]. The idea was for the [Inaudible] to the opposing launchers. Some of these launchers tried to stay high and some went low [Inaudible]. The low launchers landed in the area that we [Inaudible]. We confronted [Inaudible] in the area [Inaudible] and we came to track down this operation. The fact is that the plan was nice [Inaudible]. The pilots and officers that were on it [Inaudible] ..the</p>

	<p>fighters, yesterday. These are the things that happened in regard to the issue of operations. Sir, as for the [Inaudible] yesterday, all the units moved [Inaudible], especially [Inaudible] and the equipment that their activities were focused on. Of course they [Inaudible] activity. To the eleventh there was no activity, none on the south and none on the north [Inaudible] and the units started moving in that direction. Sir, the morale of the fighters is [Inaudible] very high [Inaudible] airplane. The Air Defense at the Cruise level... the first raid took place on Tuesday. [Inaudible] Wednesday at around 44 missiles. Iraq is proud of the high percentage of the Cruise [missiles] that were shut down. Twelve of the 44 missiles were shut down. This is a little less than 26 to 27 percent. Also the intelligence is doing a survey on the ground, target by target [Inaudible]. The loss in al-Razzazah was [Inaudible] in a hall room. This target was hit in [Inaudible] al-Kut. A missile landed; a group was injured and one died also in a hall that was targeted.</p>
Male 1	<p>Why do they use the halls? The ground soldiers are not allowed to use the halls. Go see the entire Special Guards and their number is not small, you will not find anyone in a hall.</p>
Male 2	<p>You are right, Sir.</p>
Male 1	<p>In the Gulf War they hit the halls and they found only one person who went on his own in violation of the instructions. In all the attacks on the halls we lost only one person. You, with the Air Defense, this should be the most important protection. Within the emergency plan you should have sectional trenches that are [situated] beyond the effect of the bombing fragmentation. At least if fragmentation were to take place, you would have sectional and shielding trenches with a cover on top. Just like that, you sacrifice yourself while you are fighting! You are fighting an enemy, so why do make these sacrifices? Why do you use the soldiers' halls? Why do we sit in them? What do we gather? Whatever we will need in the system [Inaudible]... is not in the headquarters. When you make a sectional trench, make the headquarters near the sectional trench in which the system is placed. The tanks will be misled and they will believe that the system is placed in there and they will hit it, while the system and its operators are in another sectional trench and sunken shields that are between two and a half by two. Two people should sit in it. Two or three sit in it and they will be beyond the effect, outside the hit zone and escape the losses.</p>
Male 2	<p>God willing Sir, God willing Sir. If you would add to the percentage of missiles that fired on these targets [Inaudible]. In a statement they said that it has reached more that 50%. In fact they have repeated the raid [Inaudible]...they hit only [Inaudible]. Sir, as for the airplanes [Inaudible] your wise orders, praise and thanks be to God, [Inaudible] are still in place and we will revisit it in the future [Inaudible] the Air</p>

	<p>Defenses [Inaudible]... but it is your Excellency [Inaudible]... in that direction. Sir, [Inaudible] the plan for redistributing the equipment that we withdrew from the areas that your Excellency ordered us to. If God facilitates, we will proceed with the process of checking, preparing them and reorganizing them.</p>
Male 1	<p>Let our schedule be in the following structure: First, I have a new idea for protecting our air defenses and for causing attrition to the enemy. I will explain it to you and then we will discuss it. The second point is the lessons learned from the operations that took place. Positive and negative lessons learned from our movement during operations and the technical usage of our equipment. At the same time, the lessons learned from the positive and negative behavior of the enemy; to go over them and discuss them. The third and the last point, or the next to last, is that yesterday I sent you a letter on how to redistribute the equipment and the Air Defense missiles. Let's present it and we'll see, I might take some note about them. Whenever I go [Inaudible]. It is not enough to say do not fire. What is needed is an answer to the question of where should the equipment and weapons go. [Inaudible] urgent message. And the fourth is, any general comments that any of you have for discussion. The first idea is that the enemy [Inaudible] behaves after the danger is gone in order to make a trap and in order to learn lessons that would be helpful in case the confrontation resumes. This includes seeing our missile batteries. First is the method of [Inaudible], and then he tries through the tools of maneuvering, in which he will discover, be able to locate the positions of our missile batteries. He does sweeping and he says I see a water tank, I see four 15-ton trucks, I see a bulldozer and I see [Inaudible]. He puts everything in front of him and he says that even if I do not find the missile batteries, but I see these in all of the images, this means that there are missile batteries. He says I should deal with them with a shower of weapons from bomber aircrafts from outside...outside the effect of the air defenses. In another way, the structures [Inaudible]...how the enemy see things. If this is true, the enemy [Inaudible] tries to see how his enemy behaves while it is inactive and he does not fire on it, in order to benefit from that once there is fire and action. So what should we do? We will mix things up south of line 32. We will mix something real with something that is similar to it, with the same specifications [Inaudible] when it is photographed, or when it is observed closely. Do you have equipment for deception?</p>
Male 2	For Structures
Male 1	<p>In order to give these structures, equipment... what do they call it? Reality --make it look real. In addition to the systems that you used, we should put the same [Inaudible] guards that we use for the real launchers. For maneuvering we give it all the support that we give to the real</p>

equipment, such as a water tank, two trucks, a load of this and that, some thing like this and that. We give it and we move it. We make them come to it and see it. [Inaudible] the same equipment. Right? No wrong. It is different, different. [Inaudible] what is used in the maneuver is only capable of maneuvering. Even if it is slow. We put something here, some thing here and something there...that is it. Then that is it. Even our real equipment, which we use on the south of the line, is the same [Inaudible]. [Inaudible] he will come during the maneuver [Inaudible]. He will find it during the maneuver. In the future, they will not say that the Iraqis fired at us and we went after them but we did not find them. This time we will let them go [Inaudible] so that we can attract them. Let them fire [Inaudible]. We might present it to them and we might maneuver with it. If the maneuver is slow, they might be able to find them sometimes. [Inaudible] they will fire. First, [Inaudible] last time. They will go to it. They will become [Inaudible]. Then they will find our missile batteries. For our batteries we will use something different [Inaudible]. It is better to do more that what we have to do for the battery [Inaudible]. I prefer to do more so that if they see [Inaudible] less he will reach the conclusion that this [Inaudible] is a maneuver by dead batteries. Instead of a bulldozer, I would put two. Instead of a truck, I would put four instead of [Inaudible], I would put that. Then they are waiting for military operations. They will be confident that there is a live battery that they should bomb. What is the issue in this note? If you do this in the future [Inaudible] real action, which means that we will tell them.... This issue should be studied with all its options and we should discuss it in detail. Should we go for normal [Inaudible]? Or should we go for less [Inaudible]? Or should we aim for more? We will put the plan in place and depend on God. This is the idea that I wanted to explain to you. I expect the enemy will find our batteries by maneuvering his satellites and it is easier for their airplanes to catch the larger weapons, such as [Inaudible] and the missiles that are considered weapons that can be captured clearly, in addition to carriers and the way they are deployed. For example, we should put cars... we put them around the launcher or around every battery and keep it close, not too far, so that he would say that I am around the deployed cars and if I come 200 – 500 meters from them, I might hit the missile launcher. If he does not see it he will program it based on this. For bombing, the enemy depends on programming and this is his strong point. We should use the simple methods, in order to make his strength a weakness. We will bring the carriers closer and put them in the center. When he sees these carriers in the center, we of course will move it anyway. If he sees the launcher, he will fire at it. These carriers that we will use in the way that I described should be air defense weapons on wheels. You have them in Falujah and you have in al-Taji. The same trucks that are in the army and are not being used, should be used [Inaudible] or removed. If it is possible to remove them, we will remove them. If it is too hard and we need a

	<p>crane...this is difficult process. We should sacrifice other carriers. [Inaudible] take when it stops. We will attract our enemy and disable him. We should affect his morale. His morale was greatly damaged lately, because America appeared [Inaudible] unable to fight the Iraqi fire. This has exposed it to the world. Why? Because [Inaudible] they are there. Our weapons are not Iraqi [Inaudible], the Iraqis have made some clear developments on them. This gives new image about the achievement of a small county against a superpower. He failed the force of the superpower. They are coming to us saying for the sake of God [Inaudible]. Why when Israel speaks two words they shut-up? What is Israel? For America Israel is a small bird. When they use this method Israel will be gone because all of the weapons of Israel are American made. They can affect it, it cannot affect them. [Inaudible] its goals are permanent and known. This is the conclusion of the idea. Discuss it in detail amongst yourselves and let us start the detailed discussion. In conclusion, this idea is to make [Inaudible] a deception with the fake weapons during the time of ceasefire. We will use it for maneuvering to the south of line 32 and to the north of line 32 [Inaudible]. If they become stupid and say attack it and if they do attack it, they will be attacking something that is not there. Our missiles will would go after them and at the same time we would not allow them to get the image that we withdrew our missiles during the ceasefire. We should convince them that our missiles are everywhere [Inaudible] and that the fire has been ceased until a later time. That is it. The discussion is over the idea, not the little details. Yes 'Uday</p>
'Uday	<p>We are supposed to [Inaudible] the idea with the maneuver. We now are going to withdraw from the sites that were originally [Inaudible]. We should not rush to withdrawing. We should withdraw; I am not saying we should not withdraw. We should withdraw piece by piece to the sites...</p>
Male 1	<p>These instructions... these instructions we will get to and that was only for last night until I met you today, because every now and then we took [Inaudible], but not one if we should stay or withdraw or how to withdraw and how to maneuver. I did this to cover it now. Now I am trying, God willing to discuss our long-term idea. As I told you, the conclusion of the idea is that I want the maneuvering to continue, but it should continue in a fashion that is the opposite of the method that we are used to, in order to prevent the enemy from reaching conclusions and programming. We should make him make his calculations and programming contrary to our plans. Instead of leaving the site in two minutes or twenty minutes, this time they should leave in four, two or three hours. So he programs accordingly and he will fail. Live batteries and dead batteries. So as an idea...as an idea, not details, do you have any objection? The Minister of Defense.</p>
The Minster of Defense	<p>Thank you Mr. President Leader. Mr. President Leader, my opinion is [Inaudible] for the batteries [Inaudible] the real batteries. The enemy</p>

	does not know that they are real or not real because they have to be very similar in its exterior appearance [Inaudible] and its activities and in selecting the site [Inaudible] because first [Inaudible]. If we leave it for a long time that would be different from our habits, they will discover it easily [Inaudible]. Selecting the site by its effectiveness [Inaudible] and by the timing of the movement. Thank you Sir.
Male-1	Yes Lieutenant General Mzahim
Lieutenant General Mzahim	Sir, about the technical equipment and the structural equipment, during my visits I noticed that the directions were given in a rush and the fake equipment did not look like the original equipment. So there is a body or missile with parts missing [Inaudible], or for example a base they use...I think the enemy's capabilities in surveillance and imaging...If it does not look realistic it will not pass. If it was dead and used it should be reassembled [Inaudible]. We should depend on it and just simply bring a stand and install a missile on it and consider it a launcher or a cabin. The available equipment should be evaluated [Inaudible]. We are fighting an American enemy and just... If it were Iran's level, then it could pass and maybe a year passes without them discovering them. But with the American enemy, there needs to be some credibility because they have specialists that will look at each piece of equipment and say yes this is possible. Sir, [Inaudible] at least a month or two to discover it, but on the first surveillance mission.

Lieutenant General Mzahim	Yes Sir.

Male- 3	It is more Sir, we, in the war with Iran [Inaudible]. The Arab world, in Saudi Arabia or in Kuwait many [Inaudible]... all the people are with us, but their leaders
Male- 1	It will be OK
Male- 3	Thank you Sir
Male- 2	The truth is that I want to comment on the [Inaudible] maneuver. We have evidence from our sites and everything [Inaudible] in a leadership position that are there [Inaudible] number [Inaudible] in you direction
Male- 1	Our goal against the airplane is not to shoot down or to kill a few Americans. Our goal is to break the spirit of the Americans so that their

	aggression does not affect us. Isn't that our Goal?
Male- 2	Yes Sir, It is
Male-1	OK, lately the Americans [Inaudible] airplane, but where is it now?
Male- 2	Thanks to God, Sir.
Male-1	It became 10 kilometers high. If they became even [Inaudible], we broke their spirits. Now even their politicians, yesterday, asked the American president what are we [Inaudible] gaining? [Inaudible] in relation to Iraq from the prospective of the traditional maneuvering. [Inaudible] this is a missile, this kind and this kind. They are on alert and confused. Their confusion is caused by the way we engaged militarily and because of the international and the Arabic reaction. Now every action is very costly to them. If we were to achieve our goals, it is not important to shoot down a pilot or an airplane; what is important is to make the morale of these countries have as little as possible affect on you, even if 5% was damaged by the damage [Inaudible].
Male- 2	You are right.
Male- 3	Just one minute so that I can finish my sentences... Sir, you might have not received this information. I just spoke before the minister and Lieutenant General Mzahim. The Awacs airplanes revealed movements and uncovers airplanes and are capable of firing from heights that can reach up to 500 miles [Inaudible] the reconnaissance capabilities. The day before yesterday, our airplanes confronted them and they entered Syria for fear from our batteries [Inaudible]. So Sir, this is not right, not right [Inaudible] with their capabilities and the electronic warfare and the Awacs and their airplanes. Some times there are ten units are located in the north [Inaudible]. We have returned two or three batteries. This is not right Sir, nor right.
Male-1	I want to tell you [Inaudible] and I am not saying to raise your morale, because your morale is high, thanks to God.
Mail- 2	Excuse me Sir, [Inaudible] tell you and please you to know that the performance of the fighters with the batteries that they are working on through the developments that were added to them and the work that was done on them, they are [Inaudible]. Mr. President Leader, may God protect you, [Inaudible]. The fact is that [Inaudible] technical equipment for the air defenses [Inaudible]. Our information is for the decision maker [Inaudible] in the leadership [Inaudible]. This pilot is looking for this and this is looking for that [Inaudible] with full obedience [Inaudible]. Sir, the enemy thinks [Inaudible] because the fire ceased [Inaudible] the firing that happened.

Male 1	Do not feel [Inaudible]. You do not know [Inaudible] feel that you are restricted by this principle.
Male 2	Sure Sir, yes Sir.
Male 1	This means that you will lose the opportunity that the enemy is telling you in a clear voice...what is he doing? He is learning from you, what ever you do. He will realize that he has a problem that should be fixed.
Male 2	Sir, [Inaudible] all of this [Inaudible] for every fighter. Sir, the truth is that everything for the fighters [Inaudible] the enemy, Sir, it is the issue of firing on him [Inaudible] we [Inaudible] very detailed information [Inaudible], very detailed information about the battery [Inaudible]. Now sixty, now fifty, now forty and he just follows the direction and now twenty five [Inaudible] he transforms the radar or [Inaudible].
Male 1	[Inaudible]
Male 2	Excuse me Sir.
Male 1	[Inaudible] but in different direction.
Male 2	Yes Sir, the issue of guidance information [Inaudible] we are working on [Inaudible]. [Inaudible]a Battery and it includes a central point for transferring the radar information [Inaudible]. Sir, we now [Inaudible] and they are giving the same information [Inaudible] and if he does not have the radar, he will use the [Inaudible]. We took the information from the radar [Inaudible] and I gave it information about the fire range [Inaudible] computers. Sir, if we want to prevent the enemy from having a chance we used [Inaudible]. He has information [Inaudible] 60, 50, 40, 30 and 25.
Male 1	You tell the people on the ground that the enemy is [Inaudible] in distances.
Male 2	In distances.
Male 1	In your direction and in distances.
Male 2	In distances, from a person sitting in the radar. This means transmitting live information [Inaudible].
Male 1	[Inaudible] he listens.
Male 2	[Inaudible] information and he listens
Male 1	Are his systems capable of narrowing the range to a kilometer or not?

Male 2	No Sir, it gives it for every five kilometers. But he could [Inaudible] Sir. It is forbidden to open [Inaudible] until they are fired at [Inaudible] in order not to give the enemy the chance to fire at him when he sees him on his monitor [Inaudible]. Sir, the fighters fire at a very high airplane, if the airplane falls he knows on his technology that he has reached 25 [Inaudible]. Sir, now there is a psychological operation...they saw the airplane coming with 9 or 8.5 and there is a difference. It is coming with the margin of error of 500 more or less. So it might be 8.5 and it might be less [Inaudible]. The enemy comes nine [Inaudible], possibly [Inaudible] 5%, 10% [Inaudible], which means [Inaudible]. the pilot will be afraid of this operation.
Male 1	To be just to our enemy...he is not a coward in his nature, he is coward in his cause. He does not have cause... he does not have a cause. [Inaudible] he is acting towards his homeland or people [Inaudible]. What is his relation to the issue of Kuwait? That is it. Practically he is weak. Politics is a moment of consideration not a legitimate choice that they deal with this way. As for the issue of capabilities, or I should say force... force is better, because capability includes justice, but force does not include justice. They are based on unjust force. They take their steps based on the unjust force [Inaudible]. We will not go to Washington. Even people in his party are asking him if there is no UN resolution that keeps them from having the right to confront a military force [Inaudible]. So they do not have a cause.
Male 2	Yes
Male 1	They are not cowards by nature. No, we should be fair. They are a people that have the coward and the brave. But in addition to the history they do not have a cause. You need a cause. One that does not require explanation.
Male 3	Sir, there is one point...
Male 1	No, do not interrupt Mahdi.
Male 2	Mr. President Leader, may God protect you, for them Sir, the good lessons [Inaudible] is the relationship between the resistance [Inaudible] especially during the battle [Inaudible]. I told him do not move [Inaudible] information [Inaudible] in one hour he left the area and went in another direction [Inaudible] first, according to the directions of your Excellency [Inaudible]. He said that he has four launchers and helicopter [Inaudible]. Thanks to God, this was implemented [Inaudible]. Then the issue of trenches [Inaudible]. There are trenches [Inaudible] and missiles with a deceptive sign and a black blanket. The other part is a park, where

	they fire and go back to the park [Inaudible]. These Sir, can [Inaudible]. We are very happy that the same plan that you discussed two years ago [Inaudible] the mobile missiles [Inaudible] north of line 33 and how that decision was reached [Inaudible]. One [Inaudible], one in Basra [Inaudible] Sir. And we returned the weapons to their locations.
Male 1	[Inaudible] two missiles [Inaudible].
Male 2	Sir, we did what you [Inaudible] that you talked about [Inaudible]. The missile defenses that are in the south of line [Inaudible] and one in al-Nasiriyah and another one Sir is in Basra [Inaudible]. We also have the Al-Kut area. Al-Kut [Inaudible] line 33 [Inaudible] 33 [Inaudible].
Male 1	And the remaining?
Male 2	The remaining Sir?
Male 1	The one they have remaining [Inaudible]. The maneuvers that took place... they stayed there.
Male 2	[Inaudible].
Male 1	The forces will return to using the central the way they used to before.
Male 2	Small presence and we will withdraw the rest. [Inaudible]. the firing instructions of your Excellency [Inaudible].
Male 1	We should withdraw the radars.
Male 2	Yes to the 36 <sup>th</sup> .
Male 1	With time, the behavior of the guys changes and they become less careful, including the places they hide in and the shelters [Inaudible] pull them [Inaudible].

Male 1	Yesterday, in their statements that we read, they are satisfied with what happened. It took a burden off them because our friend, he is his own friend. His issue is [Inaudible] in the future because on one side it is paying and on the other side they tell him come explain to us what are you doing? You turned the world against us and you are the aggressor, you are unjust to the man. At the beginning he did not want to be implicated but he was pushed by the English... they put him in this position. Yes Qusay.
Qusay	Sir, more than one year [Inaudible] they have prepared using the Mig-21. the Minister of Defense was there too. There was discussion between the Air Defense and the Defense Forces on the use of the fighters. A suggestion was presented and Lieutenant General Mzahim remembers it because he was there. Lieutenant General Hakam said that the Mig-21 could be used in spite of its limitations against the missiles and fighters [Inaudible] the main street for going in the fast lane. [Inaudible] if you give orders to those responsible [Inaudible] Lieutenant General al-Hakam.

Male 3	<p>Sir, Our analysis yesterday morning with brother Mahdi... they acted [Inaudible] happy at the end of the day, yesterday...they were happy. We were [Inaudible]. I told him what is this work? First they penetrated [Inaudible] 33 and all their activities were on 32 in high altitude. They went up [Inaudible] and since yesterday, they have been [Inaudible]. This is one possibility; the other possibility is [Inaudible] is ready Sir, [Inaudible]. Sir, you said that you were victorious but in all their public statements they have been saying that they will expand their attacks to other targets [Inaudible]. They expanded the targets for a large attack [Inaudible]. Some of the issues that made them really incapable is that the surface to surface missiles looked real [Inaudible]. They cannot believe the fact that they did not hit any of our launchers. Even when they talk about politics [Inaudible] to move the airplanes [Inaudible] because the missile batteries [Inaudible] approach the airplane from faraway.</p>
Male 1	<p>This is bad idea because whenever we use the airplanes of al-Saqir and the Shabah they all fall, because what does it mean the F-16, F-15, F-14 and F-18 [Inaudible]. All the people know that these airplanes exist, so why they need the F-17? The need is clear, all of these airplanes and the Cruise Missiles, the big catastrophe, were not able to achieve the goal of the American president to silence the Iraqi air defenses. This is the title. So [Inaudible] when he brought the airplanes they gave that advice. Gradually America is paying a high price against Iraq, because Iraq is not a superpower. If it was a superpower they could say that we have a problem in the technology and we should develop something. This means that after a while, the American citizen will say that I am paying money for unneeded and expensive developments and practically worth nothing against little countries... against large countries such as myself, I have missile that carry nuclear bombs, therefore there is no need for developing these weapons after they discovered that useless through the evidence of [Inaudible].
